Uvodne napomene

Selektivna bibliografija o temi religije i izgradnje mira nastala je u sklopu istraživanja Master programa „Međureligijski studij i izgradnja mira“ koji organiziraju tri teološka fakulteta u Bosni i Hercegovini, Fakultet islamskih nauka Univerziteta u Sarajevu, Katolički bogoslovni fakultet Univerziteta u Sarajevu i Pravoslavni bogoslovni fakultet „Sv. Vasilije Ostroški“ u Foči, ali pri Univerzitetu u Istočnom Sarajevu.

Bibliografija se sastoji od knjiga, zbornika, priručnika, naučnih članaka, leksikona, hrestomatija i časopisa na bosanskom, crnogorskom, hrvatskom i srpskom, te na engleskom jeziku.

Izvori korišteni pri izradi bibliografije bili su na internetu dostupni katalozi biblioteke Fakulteta islamskih nauka, online katalog Gazi Husrev-begove biblioteke, bibliografsko-kataloška baza podataka COBISS, Katalog Knjižnica grada Zagreba i online katalog izdavačke kuće El-Kalem. Na engleskom jeziku pretraživane su online baze <http://gen.lib.rus.ec> i <https://sci-hub.se>, te internetski pretraživači.

*Mjesto za drugog u našoj vjeri i životu*⁴ kao i časopise na engleskom jeziku: *Journal of Peace and Research*,⁵ *The Journal of Philosophy*,⁶ *Zygon: Journal of Religion and Science*,⁷ *Journal of Conflict Resolution*,⁸ *Journal of Islamic Thought*⁹ and *Journal of Ecumenical Studies*.¹⁰

Ključne teme ovoga istraživanja bile su: religija i izgradnja mira, abrahamske religije i izgradnja mira, pluralizam, tolerancija, praštanje i pomirenje, razrješavanje konflikta.

Vanredno stanje izazvano pandemijom utjecalo je i na istraživanje, zbog čega je prevagnula online pretraga izvora iz online baza i dostupnih bibilotekskih kataloga, kao i literatura iz određenih privatnih izvora. S obzirom na to da je tema aktualna i da smo svjedoci da je nemoguće obuhvatiti svu literaturu o ovoj temi, ovaj popis nije iscrpan nego je istraživački pokušaj da se objedini ono što je trenutno dostupno na jezicima naroda Zapadnog Balkana, kao i da se navedu značajni izvori na engleskom jeziku.

Religija može imati veliki utjecaj na izgradnju mira i pomiriteljski ulogu posebno među abrahamskim religijama promovirajući kulturu mira i dijaloga, iako smo svjedoci nemile prošlosti gdje se religija često zloupotrebljavala, a u njezino ime vršilo nasilje. Međureligijski dijalog neophodan je jer nas uči kako živjeti u miru poštujući sve razlike i uočavajući zajedničko. Izgradnja mira podrazumijeva uključenost različitih aktera, od pojedinca i organizacija civilnog društva do institucija države. To je zahtjevan posao, a u ovom je dijelu svijeta i neophodan. Prostor Zapadnog Balkana prošao je kroz brojne sukobe, dva svjetska rata, kao i ratove devedesetih godina XX stoljeća. Iako je od posljednjeg rata prošlo više od dvadeset godina, ovdašnja društva još uvijek u javnom prostoru mir ne afirmiraju kao vrijednost. Stoga ovu bibliografiju smatramo korisnom i u promociji i afirmaciji vrijednosti mira.
